 Implement corrective actions for high-risk hazards identified in the assessment for ensuring reduction in the number of high-risk incidents and compliance with safety standards. Implementation should be immediatly after risk assessment

Priority: High

3. Develop and update safety procedures and conduct training programs twice a year for



employees to enhance employee awareness and adherence to safety procedures, reduced accident rates.

Priority: Medium

4. Schedule and conduct quarterly safety audits and inspections to monitor compliance and effectiveness for early identification of potential safety issues and implementation of preventative measures.

Priority: Medium

5. Implement a system for increasing employee engagement in safety initiatives and continuous improvement through feedback.

Priority: Medium

6. Review OHS performance annually and update policies based on findings and evolving best practices for ensuring Up-to-date OHS policies and procedures that reflect current standards and practices.

Priority: Medium

7. Regularly track the progress of the action plan and adjust strategies as necessary for effective execution of the action plan and ongoing enhancement of OHS performance.
